CL has not been able to pay rent for 4 months (Nov-Feb). CL was in the hospital for 3 weeks with COVID-19 and an issue with her leg in July 2020. She fell behind in rent at that time because she couldn't work for almost a month, and she has been having trouble catching up. Client contacted BALS and we were able to reach out to the LL Attorney and enter into a stipulation. BALS through CARES Funds administered through PCF and distributed through POC were able to pay the past due amount. In addition, the stipulation provided called for a dismissal of the eviction action once payment was received. Client was able to stay in her home with her child.
