Client was able to contact Bay Area Legal Services, the lead attorney was able to advise the client and was able to negotiate a stipulation. Landlord agreed to the stipulation and agreed to accept payments from the rental assistance program with the agreement that once funds were received then landlord will dismiss the action. Client was able to preserve his housing.
