The relationship we built with the kids and the fact that they don't want to end is success. When I started the kids were seeking a reaction out of me by saying things like "I hate art" & "I don't want to do art." (which I always was calm and said its okay that they feel that way but maybe it will change) & now I don't hear any of that. The majority of kids are eager to make art, and scream "WE HAVE ART TODAY!!" when they arrive & see me. They also feel very comfortable with me and are curious/comfortable to ask me questions. Today we focused on coping skills and two of the skills were asking for help when you need it & taking some deep breaths to calm down when you are frustrated or angry. They did a great job asking for help when they needed it and I saw some behaviors shift during the course of the session to the positive coping skills after having our discussion. Many of the kids recognized me & were so excited that I was back to do art. I got lots of surprise hugs and attention.
