I started getting into trouble with the law – in and out of jail more than a few times. I needed help but I didn't know where to get it. I asked a friend who had problems like me. I went to see a doctor, then more doctors. I was diagnosed with PTSD, bi-polar/anxiety disorder. The doctors put me on meds. I've been in homeless shelters for many years, about 15 altogether. It wasn't until I came to Boley that I got better. The group therapy really helped. They gave me a place to stay and food to eat. Now my life is more stable than ever before. I look forward to recovery and healing every day. I found the help I was looking for at Boley.
