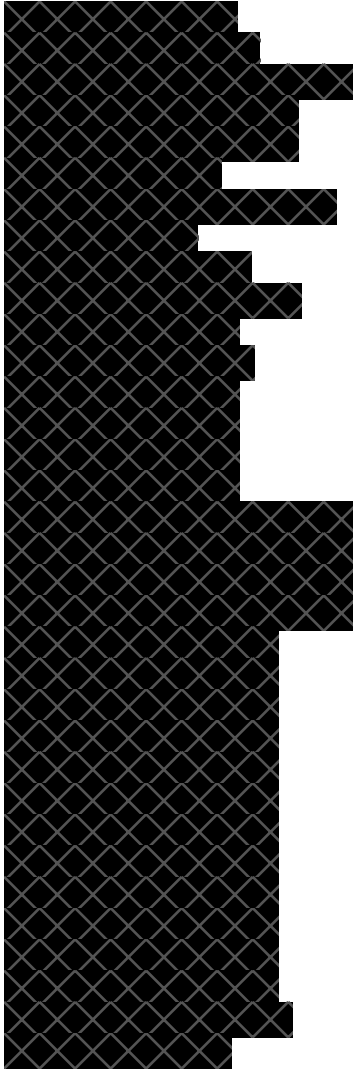

Tenant said that the staff at Community Law was supportive and kind. She remembered the names of each person who helped her. She said that getting rental assistance was a big relief. It allowed her and her family to stay in their apartment. She knows what it is like to be homeless, and she doesn't want her kids to ever have to go through it.
