#### **Organization Programming Background\***

Please describe the programming your organization offers to the community and the length of time it has been doing so. That is, what does your organization **do** and **how long** has it been doing it?

Since the establishment of the East Lake Community Library at its present location in 1999, this organization has offered free programs and services to residents of the surrounding communities. Over time, the library has become much more than simply a book depository - it is the community center, educational center, and cultural center for this area of north Pinellas County. In addition to traditional library programs such as story times, Summer Reading, and Book Clubs, the library staff have some unique offerings such as Tai Chi, Yoga, Mah-Jongg, and Fiber Arts. To meet the needs of its patrons, the library staff have brought in professionals to assist with Medicare, CPR Training, Financial Planning, and other topics of interest to the residents. During the recent pandemic, the library set up a free Vaccination Information Station to assist with registering for vaccination appointments, etc. Throughout the year, there are Sunday Concerts, special fundraising events, and guest speakers covering a wide range of subjects. Last year, our library became a Passport Acceptance Facility, one of only eight library systems in Florida to process new applications; at this time, we are averaging over fifty applications each month. We are also proud to offer a unique collection of Gizmos and Gadgets - everything from portable scanners to Hot Spots and sewing machines that are checked out for free. During the pandemic, we saw the rise in food insecurity and set up a 24/7 Food Pantry outside our doors; unfortunately, the pantry is still needed by our residents, and, thanks to the generosity of staff and patrons, it is kept well-stocked. We are also involved in many community events with such organizations as the YMCA, Rotary, and East Lake Fire Rescue and do outreach programs at local schools. Our programming and services have grown exponentially over the past ten years and, post-pandemic, we are averaging over 800 participants per month in our programs.

#### **Community Need\***

After Hurricane Sandy hit NY in 2012, FEMA classified libraries as an essential service. People are finding that in the wake of a natural disaster, getting a library up and running with Internet connectivity, air conditioning, clean bathrooms, a place to plug in your phones, or information specialists to help with insurance claims, FEMA applications, etc. really has benefits to a community that's in a recovery situation. Although places like East Lake High School are designated shelters, East Lake Community Library could be a Disaster Relief Center or "cool site" if we are able to install a generator adjacent to this building. As some have already experienced across our state, many library patrons could lack basic services for days or even weeks after a storm. According to 2020 census figures, the East Lake area has a population of over 32,000 with an overall poverty rate of 9.24%; this equates to almost 3,000 residents living below the poverty line. Furthermore, the old age dependency ratio, the number of elderly people at an age when they are generally economically inactive (age 65 and over) compared to the number of people of working age (15-64 years old), is 56% for this geographic area. All of these figures point to the need for free services and assistance after such natural disasters as a hurricane or major storm, especially for those ill-equipped to deal with such a devastating situation.

During the months and years of the pandemic, East Lake Community Library strived to keep its doors open, when possible, to meet the needs of the community. Because the library was closed from March - June 2020 followed by reduced hours of operation, there was a corresponding loss of revenue in terms of fines and fees (an amnesty was extended from March - July 2020) as well as income from the sale of donated books, etc. These two events alone left a deficit of over \$8,000 to our operating budget in the first six months followed by an additional loss of \$12,000 in the succeeding two years. This was also due, in part, to the greatly reduced number of patrons coming into the library and the transition from in-person programming to online and digital offerings. Due to mandates and concern for safety, there was a discontinuation of any fundraising programs or events for two years, resulting in a loss of approximately \$\$20,000. To keep our staff and patrons safe, money was spent on PPEs such as masks, gloves, acrylic screens, weekly electrostatic cleaning, disinfecting wipes and sprays, etc. The estimated total of these purchases came to approximately \$15,000 over the thirty months the library implemented these measures. Due to concerns for spread of the disease, public computers were reduced to four, thereby limiting availability and impacting revenue from printing services tied to these computers. Since the Community Room could not be utilized for programs or meetings due to safe distancing measures and the fact that this area was being used to quarantine library materials, there was no income from room rentals for outside groups such as HOAs. Any fee-based services such as notarizing documents or proctoring exams, since both required close contact with patrons, were also suspended. As all this was happening, inflationary costs took another large chunk of our operating income for example, during this time period, print materials increased an average of 12%. However, we did not wish to cut back on purchases for our collections at a time when our patrons needed their books, audiobooks, and DVDs to get through the self-isolation. We consistently tried to make lemonade out of the lemons we were given.

Florida is hard hit on a regular basis by storms and other disasters, and libraries across the state are called upon to respond by serving their communities in a variety of ways. They have helped prepare for and endure disasters and have worked to reassemble their communities after these events. East Lake Community Library would like to install a turn-key industrial generator onsite with electrical hookup and connections in the event of an extended power loss due to a natural disaster. The estimated lifespan for this project is twenty to thirty years by industry standards. Unlike the pandemic, when we were forced to close and/or curtail hours due to safety and health concerns, a backup generator would allow us to remain open after a hurricane, etc. to to allow for continuity of library services, provide shelter, aid, and vital emergency information to our residents, and supplement and help relief organizations. The Library could also host HHS staff to answer questions on temporary housing assistance or other available services. Staff would also expend funds to keep our Food Pantry stocked for those in need. Economically, by remaining open, the library is able to conduct "business as usual" and not incur the financial losses that occurred as a result of COVID; however, our MAIN concern is caring for our community members by providing a "feeling of normalcy" throughout the event and reducing stress levels for those who need to find relief and answers to their questions.

The number served is dependent upon if and when a disaster strikes that temporarily results in widespread power outages in the local communities AND how long the outage lasts as well as the extent of damage to local homes and businesses. The backup generator would allow library staff to offer our facilities for such things as taking a break from cleanup, recharging devices, using the library's WiFi, preparing insurance claims/aid applications, or even conducting general business activities to give a sense of normalcy during the post-disaster timeframe. The number served is an estimate of approximately 50% of our average traffic count for one month. This, of course, could fluctuate from year-to-year dependent upon the number and intensity of major storms.

As previously mentioned, the 2020 Census revealed that 9.4% are living below the poverty level in the East Lake area, which equates to just under 3,000 residents; although we have no updated figures, it is expected that, due to inflation and the impact of COVID, that number is higher in 2022. As evidenced by the continued need for our library's Food Pantry, there is a segment of the population that would be disproportionately affected by a major disaster such as a hurricane if the library were not there to provide free services and aid.

Although East Lake Community Library is not located in a QCT, we do have local patrons from a QCT tract near Tarpon Springs; this represents approximately 8% of our normal monthly traffic count. However, due to their geographic location in a flood zone, a major power outage and flooding in those areas would result in a dramatic increase in visitors to our library if ELCL were designated a Disaster Relief Center.

East Lake Community Library has made intentional, explicit connections between our engagement work and the library's importance to the community. For example, through our community partnerships, we have cultivated new customers (Passport Services at the library; SHINE's Medicare Assistance; AARP's Safe Driver Classes). Going out into the community with outreach programs also gives the library a higher public profile (story/craft program at Brooker Creek Preserve; PTA presentations at local elementary schools). During the past year, staff have worked with the Pinellas County Genealogy Society and our library recently became a Family Search affiliate library, one of only two in this county. These organizations are great partners to help promote our genealogy resources, special collections, and, in turn, we are promoting their organizations and offering to host programs given by their members, which is an excellent benefit for our patrons. Our services to the homebound and those in local ALFs provides popular reading materials and movies to those patrons who cannot come into the library. East Lake Fire Rescue has been one of our partners for many years, providing CPR Training, Tai Chi, Fireman Story Time, and the annual Hosedown to end the summer. Their presence at any library event with their fire truck and firefighters guarantees a successful day! Rotary Club of East Lake Sunrise holds its weekly meetings at our library, contributes to our food pantry, and participates in our events; in turn, the library is always a part of their annual fundraiser - the Classic Car Show at John Chesnut Park. Although we are a small library, we pride ourselves on assisting the Supervisor of Elections and our patrons by offering our venue as a ballot drop-off site for primaries and general elections and offering our Community Room for candidate forums and panel discussions with the County Commissioners. In conclusion, we believe that librarians make their value and relevance clearest when they build authentic relationships that lead to meaningful shared work in pursuit of big-picture goals.

The original lease agreement between Pinellas County and the Palm Harbor Community Services Agency (referred to as the "tenant") was signed in 1999 for a term of twenty years. A subsequent ordinance (No.13-24) and Operating Agreement with the county in September/October 2013 created the East Lake Library MSTU, a separate taxing district for ELCL and East Lake Recreation, and the Board of County Commissioners is the governing body of the district. The Division of Administrative Services has been notified of our proposal, which is standard procedure for any modifications, improvements, or additions. If this proposal proceeds to the application phase, written consent will be forthcoming, as required by the terms of the lease agreement.

on availability, cost and the County's preference due to environmental factors, etc. Once I have all of this data, I will standardize the request for bids and anticipate having three qualified bids within a month after submitting this letter of intent.

The East Lake Community Library has been fiscally responsible since it became a special taxing district in 2013. This library went from a struggling institution with no reserve funds for repairs or improvements to an organization that has been able to make great strides in the community while building a healthy capital reserve fund. All four PHCSA entities have their own bookkeepers/account managers who utilize such software programs as QuickBooks for fiscal management. Lois,

Upon reviewing the existing electrical distribution system for the 8,900 square foot public library and discussing a future need for an emergency back up generator to power the facility in times of extended power outages, we have determined that the most economical approach would be to provide a whole building generator. This would include introducing a service entrance rated transfer switch along with a generator to pick up all electrical loads for the building. This would keep the facility fully operational with a place to comfort and provide adjacent residents with necessities and direction until local power is restored to the area.

We have contacted Duke Energy, the utility power provider for the building and the peak demand over the last 12 months occurred in December of 2021 at 54.8 kilowatts. With this obtained value and following both local and national electrical codes, it is our recommendation to install an 80 kW generator with an onsite 72 hour tank for full building operation. A rough estimate of construction cost for a fully installed system will be somewhere around 100 thousand dollars to accomplish this. An exact value can be obtained with complete construction documents and specifications produced for contractor bidding by a licensed professional engineer.
