**Example:** ABC Charity has only expended \$1,000 this week on program personnel while our food pantry was open. ABC Charity buys its food in bulk on the 15th of every month, and therefore there will be an uptick in expenditure that week.

Feeding Tampa Bay expended \$148,387.53 from November 22 to November 28 on personnel, supplies, and local travel expenses. Payroll is paid on a biweekly basis. Employees were paid for the weeks of 11/9/2020 through 11/21/2020 on 11/27/2020. Supplies were also purchased for pantries and the Meals on the Go program. Meals on the Go invoices were allocated using a calculation of the percentage of meals served to Pinellas County. Local travel mileage was expensed for several mobile pantries, mega pantries and mobile drops. Capital expenditures for two truck leases are expected to be included in the next weekly report.
