Feeding Tampa Bay expended \$93,913.99 from November 29 to December 5 on supplies, local travel, and capital expenses. Supplies were purchased for pantries and the Meals on the Go program. Meals on the Go invoices were allocated using a calculation of the percentage of meals served to Pinellas County. Local travel mileage was expensed for several mobile pantries, mega pantries and mobile drops. Additionally, capital expenses were included for two truck leases. Personnel expenses were not included since payroll is paid on a biweekly basis, with the next pay date on 12/11.
