**Example:** ABC Charity has only expended \$1,000 this week on program personnel while our food pantry was open. ABC Charity buys its food in bulk on the 15th of every month, and therefore there will be an uptick in expenditure that week.

Planning and coordination of the Project began September, however the Project was not officially approved until October 8, causing a delay in implementation. In order to begin implementation of the (YMEI-COVID) Project-Behavioral Health Component, (20) laptop computers had to be ordered, purchased, and disseminated to (19) youth participants, and (1) (LCSW), prior to the first Behavioral Health Session, scheduled for November 1, 2020. In consideration of the above, on 10-8-20 Front Porch purchased 20 laptops, totaling \$4,780 from Office Depot. An additional payment was rendered for Consulting Services provided by Atilol Consulting Solutions, for the period of 9-1-20 to 9-30-20, at a compensation of \$2,250, bringing total to \$7,030.
