The SSI income was only \$750 per month, which is nowhere near enough to cover her rent and other expenses as a single woman. She was out of options, so she called GLS.

Our attorney immediately contacted her property manager to see what they could work out. The landlord was happy to work with us on getting back rent so T could maintain her apartment and avoid an eviction notice. GLS put in the request for back rent with POC yesterday and believes we will close T's case shortly.
