**Example:** ABC Charity has only expended \$1,000 this week on program personnel while our food pantry was open. ABC Charity buys its food in bulk on the 15th of every month, and therefore there will be an uptick in expenditure that week.

Last week was a light week for direct service staff. Housing staff were encouraged to take the holiday week off to recover from several months of dealing with an urgent case load. The staff putting in time last week were mostly administrative. The Volunteer Manager worked with some attorneys on pro bono matters, the Grants Manager finalized the outreach portion of the grant, and the Director of Finance reviewed spending thus far for the grant. The rest of the cost (\$4,500) was spent on direct marketing as approved in the budget amendment.

In addition, our first case was officially closed with a successful outcome of “Negotiated Settlement without Litigation.” Several others have settled but their cases remain open to finalize paperwork.
