She managed to stay on track with her rent until her car broke down in February and she had to reallocate some of her funds in order to continue getting to work. She has never had an eviction filed against her and has worked hard to provide a stable life for her child, who she hopes will go to school to get a better paying job than she has.

Fortunately, Brenda’s landlords were willing to talk with the GLS attorney, Caryn, to cover the back rent that she owed. It wasn’t a huge sum in comparison to other cases, but it made a huge difference in Brenda’s life that there was funding to cover it. She is relieved that she will not face an eviction notice and will not have to scrounge and possibly take on another job to pay the back funds owed.
