Example: ABC Charity has only expended \$1,000 this week on program personnel while our food pantry was open. ABC Charity buys its food in bulk on the 15th of every month, and therefore there will be an uptick in expenditure that week.

From November 15th to November 21st GRAYDI purchased a new Fridge/Freezer at \$8,611 to store more perishable food for our food giveaways, it will be delivered on December 11th. Because we did not have the increased cold storage for our thanksgiving bags, we decided to do 60 bags and then make up the difference to our request with 2 food bag giveaways in December. On food we spent \$5,754.04, making our cost per food bag \$95.90. Each food bag included a Turkey or Ham, several large bags of fresh produce, a pie, mashed potato mix, stuffing mix, an assortment of canned items, and tea or fruit drink mix. These bags were put together the week of the 15th and distributed on Saturday November 21st.
