Pam"Pam" came to the Homeless Leadership Alliance of Pinellas after losing her job in the wake of the pandemic and facing imminent homelessness. Pam's household consisted of her and her 4 children, 3 of whom are under the age of 5. Due to lack of transportation, it was important that Pam's family be close to public transportation. Pam got another job but had limited income, and also had a prior eviction on her record, which made Pam's housing search difficult. Unfortunately, the search for Pam's home was halted when the program's grant ended at the end of 2020. In early January, Pam's family of 5 was evicted and had to move into a hotel room. When the grant restarted in January, HLA was able to resume their housing search efforts. Her Housing Navigator negotiated with a landlord who agreed to accept Pam's family into a rental unit in February. Pam has since got a new job, making more money, and she was able to buy a vehicle to transport her family. They are very happy in their new home!
