Beth," Beth," a single mother of four, was referred to the Homeless Leadership Alliance when her family's prior living situation became untenable. Beth faced numerous challenges finding a home, including a previous eviction improperly appearing on her record (even though the judge dismissed the case) and a limited income. Beth applied for one of Pinellas County's newest affordable housing complexes right away; however, Beth's family was put on the complex's long waiting list for a unit. In late March, only a few days after entering into the HLA's Housing Navigation program, Beth received the call that she had been waiting for: a unit was finally available! After HLA negotiated with the property manager and paid move-in costs, Beth was able to secure a safe & affordable place for her entire family. Now, Beth can (in her own words) "see the excitement and joy on [her] children's faces" because of the "fresh start" that the HLA was able to help them get. They can maintain housing stability.
