During the day, she would cling to her mother. She also began having meltdowns when she made a mistake. Mother had no means to pay for counseling sessions as she was uninsured. Through the Pinellas CARES grant, we were able to initiate play therapy sessions. Telehealth sessions were enhanced with the packets that were made and distributed through our outreach coordinator. Mother complimented the therapist on the progress her child has made saying she is sleeping much better at night.
