The COVID-19 pandemic had exacerbated her anxiety and anger that was already affecting her due to her parents' recent divorce. Due to limited finances, she had not been able to see a counselor yet. Under the CARES Act, she was able to work through her presenting issues with a therapist at HOME. Through bibliotherapy, expressive arts, directive and non-directive play therapy, and cognitive behavioral therapy, she learned and implemented emotional regulation strategies for her anxiety and anger, practiced positive self-talk to increase her self-esteem, and explored her role in her new family dynamics. Both parents have helped her apply these new strategies into her daily life and have seen improvement in both her self-talk and her behavior."
