Because of the CARES grant we were able to immediately supply her with a good amount of quality food and we gave her a full Thanksgiving dinner. She cried tears of relief in our parking lot while thanking us profusely. We gave her one of the Pinellas CARES We're Listening Survey cards and told her about the CARES grant that enabled us to have all the food to assist her with.
