JLSP expended a total of \$787.84 the month of February 2021 through one Walmart purchase in the amount of \$93 for Capri Sun's and gallon storage bags and one Sam's Club purchase in the amount of \$694.84 which included fruit snacks, handi-snacks crackers, apple sauce, breakfast biscuits, trail mix, Goldfish crackers, and slim jims. Additionally, \$120.87 was spent on a once time Walmart purchase of cupcakes for the Boys & Girls Club's valentines party; however, going into the month only \$298.41 was remaining of CARES grant funding, so the February reimbursement request is for only the remaining \$298.41 - even though February program spending exceeded that amount (anything above the \$298.41 paid by JLSP out of pocket).
