Organization Programming Background*

Please describe the programming your organization offers to the community and the length of time it has been doing so. That is, what does your organization **do** and **how long** has it been doing it?

Missio Dei is a church that focuses on vulnerable members of the St. Petersburg community, particularly people who are homeless or precariously housed. We serve a meal on Sunday evening with an optional worship service before the meal. We have been serving this meal since 2015 but have offered similar community ministries on a smaller scale since 2007. Food has always been at the center of our service to the community, which we connect to Jesus' practice of welcoming people with food.

While the worship is very much optional and many people participate in the meal who do not worship with us, worship embodies the welcome and inclusion we seek to provide in everything we do. People who are homeless or otherwise marginalized do not just suffer economic difficulty, but also isolation and exclusion from mainstream society. By welcoming everyone's voice and offering belonging as well as services, we hope to provide a measure of healing. The meals we serve offer not only physical nourishment, but also opportunities for people we serve to participate in preparing, serving and cleaning up, thus nurturing their sense of self-efficacy and community.

In addition to serving the meal, we host a monthly laundry ministry called Laundry Love at a local laundromat. At Laundry Love we provide detergent, dryer sheets, quarters and pizza. We also offer small amounts of financial assistance to help people buy work clothes, pay utilities or meet other urgent needs. Financial assistance is complemented by informal guidance for people in need to connect with resources. This guidance is provided by Rev. Gregory Rolle, Missio Dei's pastor for social justice, who was homeless himself for 7 years. Additionally, both Rev. Rolle and Rev. Sam Picard, Missio Dei's lead pastor, participate in the Pinellas County Homeless Continuum of Care Board to engage in the broader approach to ending homelessness.

Community Need*

Missio Dei's services have been offered at several different locations in downtown St. Pete with a focus on people who are homeless. Many of the participants of our ministries are chronically homeless with multiple,

complex needs. The people we serve, from 30-70 people each week, struggle with food insecurity, job instability, physical and behavioral health concerns and the impacts of isolation, injustice and trauma.

Since 2020 we have been located at Dr. MLK Jr. St. and 9th Ave. S., a community facing high rates of poverty and racial oppression. Our location sits at the border of zip codes 33701 and 33705, the latter of which is one of the zip codes most impacted by racism, poverty and multiple markers of inequity in Pinellas County. According to Unite Pinellas's study of the region, 55.5% and 46.3% (respectively) of occupied rental units in these zip codes is substandard. Nearly 70% of renters in 33705 are classified as cost burdened and 48% of the people in that zip code are Black, facing disproportionate impact from the pandemic.

Our organization has faced four key areas of negative economic impact from the COVID-19 pandemic: increased need, increased isolation, decreased connection to financially stable supporters and increased cost. First, and most importantly, people who were economically marginalized before the pandemic have been further impacted by job instability, food insecurity and rising prices. This confluence of factors has increased the need for our meals and laundry services, without bringing in additional revenue to meet that demand.

Less tangibly, the isolation and disruption of the pandemic have made access to services, community and work more difficult. While the job market is objectively strong, opportunities are not evenly distributed. Our participants report feeling unstable and having difficulty meeting their needs. Additionally, many of the people we serve have criminal backgrounds that put most employment opportunities out of reach. In prior spaces we rented we had a commercial style kitchen available, which allowed us to provide marketable job training opportunities for volunteers, even for people whose background makes them difficult to employ. The need for this kind of community participation and job training opportunity is greater than ever after two years of pandemic strain.

The stress and isolation of the pandemic also took a toll on several of our key volunteers and the relationships binding them to us. Most concretely, that meant the loss of a key donor and friend, but more broadly it has

made many volunteers hesitant to engage with a hands on opportunity, which has kept those volunteers from offering financial and practical support. We hope that a better cooking space will encourage greater and more diverse volunteer participation and connection to people and organizations in a position to offer financial support to our organization.

In addition to the increased need for services, our costs have increased because of inflation and the need for COVID precautions. We have had to spend more money on cleaning supplies and food packaging as more people are taking meals to go. We have also faced increased utility costs. Our average weekly food cost before the pandemic was \$150 and now is closer to \$250. Overall our costs have gone up \$10-15,000/year since before the pandemic while our revenue has remained flat. In addition to these financial impacts, we bore the cost of quarantining our pastor for social justice at a cost of \$18,000, of which only half was absorbed by outside grant funding.

We are building a new kitchen with these funds. Currently, we are serving 40-70 meals a week with two regular domestic stoves, functional but leaking plumbing and limited and aging refrigerators and freezers. The new kitchen will not only improve our ability to cook and serve meals. It will also facilitate inclusion of more volunteers in a safe and comfortable way. Volunteering improves participants' sense of purpose, contribution and inclusion, which is healing in itself. It also offers more financially stable volunteers the opportunity to share experiences with people on the margins, which encourages financial support.

Additionally, Rev. Rolle has been a professional chef for many years. Having a professional kitchen will strengthen his ability to teach cooking and food safety skills to people who have limited employment skills. Jobs in the hospitality industry are anecdotally less limited by background checks than other industries and thus provide key opportunities to our community members to build employable skills.

The kitchen has a lifespan of 10 years or more.

A commercial stove will allow us to meet the increased need for food by cooking in larger batches. Currently, cooking for the people we serve takes a long time because the facilities are not adequate. While we can accommodate some volunteers, a better work space would allow more inclusion, better meeting the need for purpose and participation that has been exacerbated by the pandemic.

By improving our refrigerators and freezers we will better be able to take advantage of donated food and bulk purchasing. Additionally, newer units will be more reliable, reducing the occasional, but still harmful loss of food due to refrigerator malfunction. These improvements will reduce our costs and improve predictability of operations.

Our greatest single asset is Rev. Rolle, Missio Dei's pastor for social justice. Rev. Rolle has been impacted substantially by COVID as his own health is precarious and his social network, which overlaps significantly with the community we serve, has been pushed further to the edge of survival by this pandemic. Rev. Rolle was encouraged to quarantine during the first year of the pandemic, which, while intended to protect his

health, was harmful to his sense of purpose and efficacy. Having a professional kitchen where both his cooking and mentorship ministries can fully blossom will support this crucial member of our team as he supports the broader community.

Most of the community we serve is very low income and many are homeless or precariously housed. In addition, our community is about 50% Black. Both low income and Black members of the community have been disproportionately impacted by COVID. This purchase will improve current services for these members of the community. It will also increase opportunities to participate in the work we do and learn employable skills like food safety and preparation.

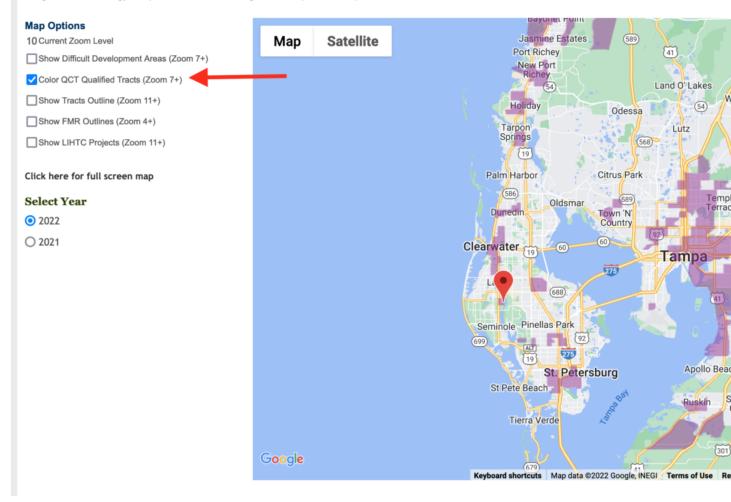

Rev. Rolle, Missio Dei's only paid staff member and the longest-serving member of the community is Black, physically disabled and formerly homeless. He is widely known in the community and is the connection point

for many of our volunteers. Many of these volunteers are also homeless or marginally housed; some live immediately in the neighborhood and others walk from slightly further away. Participants find out about our community primarily by word of mouth, and those clients are the key source of new volunteers. Thus our ministry is deeply rooted in the community we serve.

Missio Dei rents from Praise the Lord Outreach Ministries, which in turn rents from Dick Martin. Praise the Lord Outreach Ministries has rented at this location for approximately 7 years, during which time their leadership has borne most of the burden of renovations and repairs to their units. Like Missio Dei, Praise the Lord Outreach Ministries is financially constrained and serves a disproportionately impacted community.

Mr. Martin has kept the rent reasonable for Praise the Lord Outreach Ministries, which has allowed Missio Dei to rent affordably as well. The condition of this affordability is that Mr. Martin leaves repairs and management of the facilities to Praise the Lord. Neither Praise the Lord Outreach Ministries nor Missio Dei can undertake such significant and helpful kitchen renovation without grant funding.

Mr. Martin has previously given written permission for repairs and renovation and is open to projects like this.

Missio Dei obtained a bid for a similar project a year ago when we thought other grant funding might be available. As a result, we have a strong connection with a contractor and a sense for baseline costs, though costs have risen significantly since then. Our estimates are based on that bit with upward adjustments based on increased material and labor costs. We feel comfortable with this contractor based on track record and personal recommendation, but would seek additional bids if possible to ensure the best value.

This project will on balance decrease operational costs by allowing us to store larger amounts of food, thus enabling greater use of donation and bulk purchases. While the use of a gas stove will add cost, several of our current refrigerators and freezers are old and thus less energy efficient, so the impact on utilities is expected to be minimal.
