## **Organization Programming Background\***

Please describe the programming your organization offers to the community and the length of time it has been doing so. That is, what does your organization **do** and **how long** has it been doing it?

Parc Center for Disabilities provides more than 40 programs and services to 543 children and adults with intellectual and developmental disabilities. Parc is wholly dedicated to ensuring that every individual we serve is valued, respected, and embraced by our community for their uniqueness and the joy they bring to everyone they touch.

Our Children's Services department is renowned for 4 distinct Early Experiences Informed Childcare programs: Discovery Learning Center Preschool; Onsite Therapy (physical, speech and occupational) Family Focus early intervention services; and Caregiver Relief services. All services are provided by our highly trained team of interdisciplinary, trauma informed care teachers, social workers, behavior analysts, and therapists. Parc is the hub of expertise for early learning and school readiness education in Pinellas County.

Parc's adult programs embrace a "person-centered" approach that allows participants to make their own choices in an inclusive and nurturing environment. Programs include Life Skills Development; Supported Employment (a program where 51 adults are employed by over 30 businesses in the community); and the Inspired Artist Studios to name a few.

Residential services include 4 separate facilities: Curry Villa (a 15-bed group home), Burkett Villa (a 15-bed group home), The Cottages (a 16-bed Intermediate Care Facility for teens and young adults), and the Bert Muller Home (a 48-bed residential Intermediate Care Facility for adults, 33 of whom are age 50 or older and some up to 80 years of age. The Bert Muller Home has some of the county's most frail elderly, with no alternative housing who are aging-in-place at Parc, with 100 percent of the residents considered extremely low income and fortunate they are not one of the 22,759 individuals currently on a state waiting list (reported by the Florida Center for Inclusive Communities at USF, 2022) for residents with developmental disabilities awaiting services.

## **Community Need\***

Compared to the general population, people with disabilities have fewer friends, less social support and are more socially isolated. The underlying principle of this program fosters community connections among individuals who are from different ages, abilities, backgrounds, and life experiences. Working together creates a shared experience that builds a community which connects and bonds this vulnerable population, while improving their social connectedness, overall well-being, and independence. Parc's Workforce Transition Training Program currently has a waiting list of over 100 individuals with Developmental Disabilities.

According to the 2016 American Community Survey, 5 Year Estimate, 28.1% of individuals with disabilities in Pinellas County are living in poverty. This program serves to reduce the number of individuals relying on the full Federal Benefit Rate by allowing them to secure and maintain employment to supplement their benefits, thereby increasing their financial independence and becoming productive members of their community.

Due to the lingering effects of Covid-19, hundreds of local businesses are still struggling to hire and retain a reliable workforce to fill low-paying jobs. Parc's Workforce Transition Training program fills this need through job skills training, transportation support and other supports designed to ensure participants sustain long-term community employment.

The pandemic created at least four distinct yet related negative impacts within Parc's Workforce Transition Training program. First, our ability to hire and retain qualified employees to continue providing training and supervision to developmentally disabled adults already enrolled in the program. Secondly, we have a waiting list of over 100 individuals with disabilities in the community eager to secure job skills and employment offered through the program; third, the extensive waiting list has limited our ability to secure additional community employer contracts; finally, our capacity to address the above needs is hampered by insufficient space and capital resources.

A fifth negative impact is a severe organizational budget deficit of \$2 million created by Parc's Living Wage campaign. The Living Wage initiative was created to address the loss of employees as a result of the pandemic and our inability to recruit and retain employees at pre-inflation pay rates. This resulted in severe staffing shortage of direct support employees. Providing much needed wage increases will ensure Parc is able to recruit and retain highly qualified and dedicated employees for decades to come. However, this unbudgeted expense was funded through reserves, thereby preventing Parc from investing in this capital project that will allow us to expand our program and meet the community need of employing individuals with developmental disabilities, while at the same time fulfilling hiring needs of businesses within Pinellas County.

The Workforce Transition Training enhancement project includes reconfiguring and expanding the existing production staging, preparation, and warehousing areas, as well as retrofitting and purchasing updated equipment. These enhancements allow for additional space to welcome new community partners, participants, and staff thereby addressing the negative impact of Covid-19.

The below scope of work includes several areas to be addressed within a project timeline of approximately two years. This timeline will not encroach on or exceed the allotted grant funding parameters requiring completion prior to 2026.

1. Purchase of a standalone 1,600 sq. ft. pre-fabricated metal production unit to accommodate an increased capacity of contract work.

2. Replacement of original windows and doors on the existing building from 1973 where participants are working on current manufacturing contracts.

New doors and windows will provide a secure location for participants to work, and the upgraded material will help to decrease

organizational utility costs.

3. Repurposing of an existing 1,500 sq. ft. space into an area for production preparation and participant programs.

4. Purchase of equipment and materials for production, transportation, and storage to accommodate new and existing workforce production contracts.

# Will this project benefit the community members defined above that have experienced disproportionate negative impacts from the COVID-19 pandemic? If so, how?

Prior to Covid-19, our Workforce Training Transition program operated with 343 participants. During the pandemic, Parc experienced a tremendous loss of staff to supervise and train participants; CDC social distancing recommendations also forced a reduction in the number of participants in our program, resulting in just 130 participants in 2021. Since that time, Parc has hired more staff and enrollment has increased to 229 participants, with a waiting list of over 100 individuals with developmental disabilities in the community. These individuals have been forced to stay home, have no social interaction, have no purpose and no ability to earn an income. In an effort to increase participation levels, Parc is pursuing new contracts with local businesses. However, our existing facility is not equipped to handle additional production and assembly

contracts that we are negotiating, thus hampering our ability to expand the program. The capital enhancements requested in this grant will directly support Parc's efforts to partner with additional community employers resulting in a reduction of individuals on the waitlist for our Workforce Transition Training program.

## **Community Connection**



For 70 years, Parc Center for Disabilities has been a progressive leader in providing the widest breadth of disability programs and services in Pinellas County. Our Workforce Training Transition program has been in existence for 40 years and currently serves 229 individuals with developmental disabilities and has a waitlist of over 100 individuals. This program collaborates with the State Agency for Persons with Disabilities and will contribute to the State's Employment Enhancement Program along with developing additional opportunities for placement with the Division of Vocational Rehabilitation. The requested funding will also allow us to enhance our program's visibility throughout the community, increasing the number of business partners we collaborate with who are desperately seeking employees because of the pandemic. The program will also continue to partner with financial institutions such as GTE Federal Credit Union, Grow Financial and Truist who provide a variety of financial literacy workshops for program participants. On a civic level, program participants recently formed their own Civitan Charter club sponsored by the St. Petersburg Civitan Club, which allows them the opportunity to give back to their community.
