Due to her limited ability to express herself, she's been acting out behaviorally at work and at home. Through sessions at PlacementWorks, Amber has worked to express herself and put her thoughts into writing. She now shares her journal entries with family and her boos. Amber has benefited greatly from this therapeutic intervention & is thriving again at work. When she wants to indicate to her supervisor she's feeling good she places a heart symbol at her heart. Although she is very sad about her grandfather, she is more in control of her emotions & sees her future as bright once again.
