This week, Ronald McDonald House spent \$7,788.60 on groceries delivered directly to discharged patient families via Instacart. Additionally, for families currently staying bedside at Johns Hopkins All Children's Hospital, we spent \$3,672.33 on meals (breakfast and dinner) that were delivered daily to their room. We had several families utilizing our transportation services to get back and forth from the hospital to see their patients this week, totaling \$236.61. Personnel time amounted to 27 hours to keep the program running at \$30/hr, amounting to \$810.
