Example: ABC Charity has only expended \$1,000 this week on program personnel while our food pantry was open. ABC Charity buys its food in bulk on the 15th of every month, and therefore there will be an uptick in expenditure that week.

This week, Ronald McDonald House spent \$12,264.81 on meals for bedside families, and groceries for families that have already been discharged from Johns Hopkins All Children's Hospital. \$71.75 was spent on transportation via Uber to provide our families residing nearby with COVID-safe, reliable rides to and from the hospital. Additionally, our staff dedicated 22 hours (at \$30 and hour) for a total of \$660. Finally, RMH spent \$248.09 on misc supplies. We have additional approved funding leftover due to the short turn-around time for implementing this grant--setting up some of the standard operating procedures took more time than anticipated, and it took some time to gain momentum in having families sign-up for our extended COVID services.

Right around Christmas, we received a call from one of the social workers within Johns Hopkins All Children's Hospital--they had received a panicked call from a "frequent flyer" (someone who must visit the hospital frequently due to a chronic condition) who was in desperate need of formula for her infant. She thought the hospital may have extra on-hand, however the hospital is unable to provide that particular resource. I reached out to the mother, and she let us know that her WIC and SNAP benefits weren't set to come in for several more days, and that they had nothing to feed their baby; our team was thrilled to tell Mom that we could not only assist with formula, but also an additional two weeks of groceries for her entire family. This family had a full pantry on Christmas, and the weeks following thanks to the CARES grant.
