She reached out to Suncoast Center for help but struggled even coming into the building. The staff reassured her by indicating the extra measures that were being taken to make sure she and everyone felt safe and comfortable, including tele-health options and support. Carly was able to meet with a therapist on the same day, who assessed her history and developed a plan of action to help her address her anxiety. A medication management appointment was initiated to get Carly back on her medications and she is currently working with her therapist to continue developing coping skills.
