Direct support professionals are responsible for assisting individuals with personal care, health and hygiene, medication management, crisis management and many other day-to-day tasks and activities for the individuals with intellectual and developmental disabilities who attend our programs. Direct support professionals are the front line care and use PPE on a daily basis, however, individuals in our programs often do not wear PPE or may not be wearing it properly. They are educated reinforced daily to wear masks, wash hands and socially distance from others.
