	Evaluator 2		98%	No comment on "Existing Contract". I guess "Not Applicable" correct?
	Evaluator 3		93%	I'm well-acquainted with the good work of FEAST. However, their website is weak—who's on the board? Who is a contact person? Their list of partners is interesting—a combination of donors and "receivers" and that should have been clarified.

I would have wished there would have been some discussion about partnering—schools, health care organizations, specific physicians (pediatricians for example) or community-based organizations.. At the same time, I have tremendous respect for this small but dynamic organization.

In addition, because of the amount of their request and the nature of the service that the organization appears to provide, other assumptions have been made in the scoring of this application. More data would have been helpful. Questions: Why didn't the organization ask for reimbursement in their application?
