Dr. Traci's House is a 501c3 organization founded in 2020 by Dr. Traci Thompson MD, a board-certified internal medicine physician with over 20 years of experience as a physician executive and who has lived in the Tampa Bay area for over 13 years. Dr. Traci's House is a community-based clinic that brings an integrated and holistic approach to building a healthier community from infants to older adults with key resources in their very own community to create a sustainable model for generational health and wellness. By holistically combining the medical, behavioral, nutritional and social aspects of its clients, Dr. Traci's House's objective is to build a community development blueprint for 21st century urban living to address the specific social risk needs of a given community, resulting in improved health equity. Dr. Traci's House in partnership with New Vision Behavioral Health Inc,(NVBH) led by CEO Zaneta Ellison LMHC is submitting this Letter of Intent for the Clearwater ARPA Social Services Funding, Phase II, focused on Mental Healthcare and Youth & families to specifically serve the residents in Clearwater.

Dr. Traci's House started across the bay in Tampa Bay and is actively seeking to expand to Clearwater to bring the Dr. Traci's House model to the Clearwater community. The mission of Dr. Traci's House is to holistically revitalize the local community to achieve health equity and wellness so everyone can live their best life. The commitment to the community is its brand promise—"Better Health. Better Communities" and Dr. Traci's House carries out its mission, one child and one family at a time. With receipt of the American Rescue Plan Act (ARPA) funding in our Clearwater, FL, location Dr. Traci's House and NVBH are committed to providing integrated mental healthcare services through the Clear Vision Pathways program that address the whole person, inclusive of any medical, social or other behavioral health conditions that impact their everyday life. Families in Clearwater with unique complications in accessing counseling will be provided with multiple counseling options in-person, virtual/telehealth, and after-hours appointments. We propose to annually serve 300 individuals through core services (individual counseling services, family counseling services, group counseling services, and mental health resiliency workshops with topics including stress management, coping with grief, self-care and trauma informed practices).

# History in Clearwater\*

Why PCF asks this: Given that the City of Clearwater is the funding source for this grant program, PCF may prioritize organizations headquartered in Clearwater or those that have a strong presence in the City.

Dr. Traci's House and New Vision Behavioral Health Inc. were recently awarded \$100,000 each in grant funding specific to the North Greenwood Community to provide youth educational, mentoring, tutoring, and mental health and wellness services, respectively. Dr. Traci's House has been active in the Tampa Bay community, adopting local schools for mentoring and literacy workshops. Since 2018, New Vision Behavioral Health Inc. has been servicing residents of Clearwater through The Florida Division of Vocational Rehabilitation, Clearwater branch. As an active Pinellas County organization, New Vision Behavioral Health has annually hosted a free Mental Health Awareness & Youth Empowerment Summit for five years. 2021, the summit was hosted at the St. Petersburg College, Clearwater campus. This one day of empowerment has impacted youth and families throughout the Pinellas County area and attracted annual donors such as St. Petersburg College, Juvenile Welfare Board, and Johns Hopkins Healthy Start Coalition.

#### Outcomes\*

#### Example

80% of youth involved in peer counseling will show increased emotional intelligence after six months of participation.

Why PCF asks this: PCF considers measurable outcomes to be a cornerstone of effective social service programming. Tracking outcomes allows both an organization and its supporters to know how effective its programming is and helps an organization improve its programming over time.

NVBH currently provides mental health counseling services to youth/families in Pinellas County Truancy Intervention Program Services and Bethel Community Foundation's DJJ Florida Network of Youth and Family Services Child in Need of Services/Family in Need of Services. Services include biopsychosocial assessments, individual and family counseling, substance abuse intakes and counseling, Anger Management groups, active parenting groups, and individual counseling services for parents. During the Fiscal year 2021, NVBH served 65 youth and families through the Bethel program: 30% of those youth were involved in some form of juvenile diversion and 50% of that population were faced with felony charges had they not completed the program. Outcomes for Clear Vision: Eighty percent of participants who complete at least 4 out of 6 counseling sessions in the Clear Vision Pathways program will experience improved number of healthy days per month and a decrease in their Perceived Stress Scale.

#### Measurements\*

Peer Counseling Services administers the Schutte Self Report Emotional Intelligence Test before counseling begins, and in six-month intervals thereafter.

Why PCF asks this: PCF would like to know how the outcome(s) you've specified are measured, and if you used a validated tool that has been proven in usage outside your organization. If you've developed your own tool, please describe how it was made.

Clear Vision Pathways Program will utilize various clinical assessment tools to assess the needs of the clients and measure outcomes from program participants.

ACE assessment: ACE stands for "Adverse Childhood Experiences," which accesses traumatic experiences you had during childhood, such as domestic violence or sexual abuse. ACE scores range on a scale from 0 to 10, with a higher score indicating more negative childhood experiences. ACE assessment will be conducted at baseline and every 3 months while in the program to access if any changes or increases in Adverse Childhood Experiences occur.

Clear Vision Pathways will utilize the Perceived Stress Scale at baseline and reassessed at every other visit. The Perceived Stress Scale (PSS) is a classic stress assessment instrument. Initially developed in 1983, the tool remains a popular choice for helping us understand how different situations affect our feelings and perceived stress. The (PSS) is the most widely used psychological instrument for measuring the perception of stress. It measures the degree to which situations in one's life are considered stressful. Items were designed to tap into how unpredictable, uncontrollable, and overloaded respondents find their lives.

Additionally, Clear Vision Pathways will also use the Centers for Disease Control and Prevention Health-Related Quality of Life "Healthy Days Measures" at every visit to assess and track the number of healthy days perceived by the client. The questions include: Would you say that in general your health is excellent, very good, good, fair or poor?; Now thinking about your physical health, how many days during the past 30 days was your physical health not good?; Now thinking about your mental health which includes stress, depression and problems with emotions, how many days during the past 30 days was your mental health not good?; During thee past 30 days, how many days did poor physical or mental health keep you from doing your usual activities?

# **Grant Impact\***

Why PCF asks this: The intention of this grant is to fund organizations providing support for individuals and families in Clearwater with emergency housing and social services needs. How that support happens, and how this grant could help, differs from organization to organization. PCF would like to know specifically how this grant would help your organization and the clients you serve.

Clear Vision Pathways aims to target Clearwater youth and adults who are experiencing the following mental health conditions:

- · Youth and teens that have demonstrated behavior issues.
- · Youth and teens with a history of juvenile delinquency and juvenile detention center.
- · Families that have demonstrated conflict and crisis issues, and Seniors that have demonstrated mental health, kindred care stressors, and well-being

issues. Having experience serving under-resourced areas in the Tampa Bay Area, Dr. Traci's House currently serves the most impoverished neighborhoods/zip codes that show the greatest socioeconomic and access needs. Dr. Traci's House aims to directly impact health equity by restructuring and empowering the community within the very zip codes that currently correlate with worse health outcomes. Through its

comprehensive and high-quality programming of holistic wellness services inclusive of behavioral, physical and social services in the Clear Vision Pathways Program funded by the Clearwater ARPA Social Services Funding, Phase II, we strive to achieve the following outcomes:

The resiliency workshops are well attended.

The Clearwater community will be fully engaged in the referral process and actively refer youth and families to our Clear Vision Pathways program for mental healthcare.

Reduced stigma toward mental healthcare within the Clearwater community as evidenced by Clearwater families actively engaged in services, attending group and individual sessions, providing positive testimonials and increased community partners and other stakeholders such as churches, other local and non-profit organizations.

Increased access to care with participants utilizing multiple treatment options i.e., virtual or in-person, hybrid.

Increased referrals from neighborhood stakeholders and community members for mental healthcare services through Clear Vision Pathways.

Participants will have resolved or be actively resolving initial areas of needs/conflict. Participants with improved number of healthy physical and mental health days as measured by the CDC's Health Days Measure. Participants will have learned coping skills and strategies to address identified and future stressors, as evidenced by a lower score on the Perceived Stress Scale

Counseling services for individual, group and virtual/telehealth sessions will be performed by a licensed mental health counselor: 300 individuals or families at \$100/session for total of 6 sessions= \$180,000 Monthly Resiliency Workshops total of 9-12 per year (\$250 per workshop)=\$3000 Process Groups: 1 to 2 per week with a total of 60 groups per year at \$100 per group from \$6000 Social services support by community healthcare navigator during the 13 month Clear Vision Pathways program at \$500/month= \$6500
