The Mobile Food Bank distributes food to multiple areas of Pinellas County five days a week. It supplies a surplus of food to at-risk and vulnerable residents who are classified as either living in a food desert, without transportation, elderly, homeless, low-income/no income, or disabled. Some Clearwater residents fit these demographics and are served by the food mobilized to at-risk communities within Clearwater.

The food bank distributes provisions that consist of the traditional food pyramid for balanced meals, and the Food Bank Director provides nutritional information and meal cards for unique items. In 2022, the mobile food bank distributed over 1.6 million pounds of food and over 12,000 pre-packaged youth meals and brought in approximately 1.4 million pounds of food from 150 local suppliers.

The Mobile Food Bank's ability to mobilize into underserved communities supports FLDC's mission and vision to provide resources, empower residents and promote self-sufficiency.

Why PCF asks this: The City of Clearwater has indicated that this funding should be directed to programming addressing urgent needs.

According to the U.S Bureau of Statistics, the Consumer Price Index for All Urban Consumers (CPI-U) for Tampa-St. Petersburg-Clearwater states prices are up 7.3 percent over the past 12 months. The index for all items less food and energy increased by 9.0 percent over the past year. The food index continued to rise 7.5 percent over the last 12 months. Feeding America places Pinellas County's food insecurity rate at 10.6% with the average meal costing \$4.18.

The Pinellas County ALICE (Asset Limited, Income Constrained, Employed) report has almost 52,000 households at the poverty level and almost 152,000 households at the ALICE level. That leaves almost half, or 48.5 percent, of the county at an ALICE level or lower. Members in our communities are making healthy food sacrifices and allocating dollars towards other necessities, such as medication, rent, or utilities.

Individuals facing food insecurity lack access to nutritional foods and experience related hardships. They are also at greater risk of health issues such as diabetes, obesity, and chronic and mental health disorders. This puts a burden on an individual and adds excess pressure and costs (such as visits to local urgent care or emergency rooms).

History in Clearwater*

Why PCF asks this: Given that the City of Clearwater is the funding source for this grant program, PCF may prioritize organizations headquartered in Clearwater or those that have a strong presence in the City.

Since 2018, the Florida Dream Center's (FLDC) Mobile Food Bank has been distributing food services to residents in the City of Clearwater. The designated sites are mobile home parks (MHP), Housing Authority apartments, family centers, smaller pantries, and churches. Those who are served include at-risk individuals within vulnerable demographics consisting of low-income or poverty levels. Many of the demographic include low-income, homeless, veterans, seniors, and those who face disabilities.

Our Mobile Food Bank Director regularly meets with Pinellas County Housing Authority case managers, Mobile Home Park managers, Church Pantry Coordinators, and Family Center case managers to re-evaluate the need and determine if other services could help the area. In many cases, these discussions have resulted in our Resident Advocacy case managers visiting sites once a month to aid with benefits enrollment or employment resources and services.

The Mobile Food Bank supplies nutritional food to 935 unduplicated and over 2500 duplicate Clearwater residents over the course of a month. The City of Clearwater sites includes Clearbay Terrace, Continental Inn, Creekside I and II, High Point Family Center, Mariners Cove (MHP), The Point Church, Gulf to Bay (MHP), and Cross Point Open Arms. Overall, the Florida Dream Center provides almost 30,500 (duplicated) persons per year supplemental nutritional meals, allowing them the opportunity to improve their health equity by spending their restricted income on essential medication and doctor's visits.

The Florida Dream Center offers materials in English, Spanish and Vietnamese. In regards to Spanish speaking, FLDC has staff and volunteers who are bilingual. The organization also has partnerships with other organizations who are able to offer bi-lingual services, typically through appointment. Staff is also trained to utilize applications such as Google Translate through various client diversity trainings and meetings.

The food will also assist in supplementing costs for other necessities such as medical care.

45% of those receiving food distribution through this funding will better understand proper nutrition and reduce the potential health hazards of undernourishment with items provided by the Mobile Food Bank.

The Florida Dream Center utilizes the Arizona Self-Sufficiency Matrix (ASSM). In order to support the outcomes stated in this grant, the objective is to raise the points in specific categories. The residents will be

asked to complete four sections within the matrix every six months, starting with a baseline intake. These categories include:

Food - (1) No food or means to prepare it. Relies, to a significant degree, on other sources of free or low-cost food. (2) Household is on food stamps. (3) Can meet basic food needs, but requires occasional assistance. (4) Can meet basic food needs without assistance. (5) Can choose to purchase any food household desires.

Health Care Coverage - (1) No medical coverage with immediate need. (2) No medical coverage and great difficulty accessing medical care when needed. Some household members may be in poor health. (3) Some members (e.g. Children) have medical coverage. (4) All members can get medical care when needed, but may strain budget. (5) All members are covered by affordable, adequate health insurance.

Life Skills - (1) Unable to meet basic needs such as hygiene, food, and activities of daily living. (2) Can meet a few but not all needs of daily living without assistance. (4) Can meet most but not all daily living needs without assistance. (5) Able to meet all basic needs of daily living without assistance. Able to provide beyond basic needs of daily living for self and family.

Other - (1) I chose not to use the recipe cards or cook any nutritional or unfamiliar food provided by this organization. (2) I eat the food and use the recipe cards provided but have not seen any financial or health benefits. Why PCF asks this: The intention of this grant is to fund organizations providing support for individuals and families in Clearwater with emergency housing and social services needs. How that support happens, and how this grant could help, differs from organization to organization. PCF would like to know specifically how this grant would help your organization and the clients you serve.

According to Floridahealth.gov, 15 percent, or 144,000, Pinellas County residents face food insecurity with 4 percent, or 38,500 residents having limited access to healthy food options. Pinellas County is also faced with 26 percent of adults who battle with obesity. Through the Mobile Food Bank, FLDC is able to provide meals of nutritional value helping combat the battle against obesity and the many health issues associated with chronic diseases and lack of proper sustenance. Residents within the City of Clearwater limits are able to use the additional food per month to assist with other necessities in their daily lives such as doctor visits and medications.

The Clearwater ARPA funding will allow the Florida Dream Center's Mobile Food Bank to bridge the gap within Clearwater communities where poverty and hunger are prominent. The mobility of the bank is a benefit to homebound and transportation-challenged individuals who are not able to feed themselves without support. By accessing these at-risk areas, Florida Dream Center will be able to focus on community members that are in need of beneficial sustenance in order to have an opportunity for self-sufficiency and health equity. These areas can also benefit from our mobile case management services on a rotation and appointment basis.

Reduction in Funding*

The Florida Dream Center will be actively seeking and researching funding opportunities to support our Mobile Food Bank. If full funding is unavailable, additional resources will be recruited and services may be limited until such time as funding is established.

The Florida Dream Center team markets and promotes continuous donation campaigns, food drives, and organizational presentations as ways of recruiting private donations or corporate sponsorships. This practice will continue throughout the year to ensure services can continue. In addition, the grant team researches and submits for grants that can also provide additional support to program costs.

Sustainability*

The Florida Dream Center is currently funded by other organizations and government agencies, as well as actively seeking potential grants and funding year-round to sustain the Mobile Food Bank, as well as the remaining three programs. Foundations and charities that are food focused, such as WaWa and Publix, are active supporters of the bank. Precautionary measures are made to keep the Mobile Food Bank functional and operational. In addition, the Food Bank has partnerships with other local organizations like St. Petersburg Free Clinic and Feeding Tampa Bay.

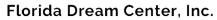
